Why is my Citizenship case taking so long with USCIS? I have a brother, and when he filed for Citizenship two years ago, it took less than six months.

This problem will make any dog howl in the night! My mom and dad worry about processing times with USCIS too, but unfortunately, all you can do is wait. They recently met with the Washington, DC District Director, Sarah Taylor, and the Norfolk Field Office Director, Frank Reffel at a luncheon and were told that Naturalization cases are taking from 10 1/2 months to 15 1/2 months. These fine folks said that now that they are interviewing all green card applicants for employment cases, there is a major backlog for all interviews, not just U.S. Citizenship. Processing times can also be found at https://egov.uscis.gov/processing-times/ Good luck with the wait. I guess the only good news with this is it gives you more time to study for that test.

Today, I can finally say that after applying for citizenship and passing the civics portion of the interview, I will soon be sworn in as a citizen of the United States. I have been blessed to have had phenomenal attorneys like Gardner & Mendoza and great organizations like AILA (American Immigration Lawyers Association) at my side to make this day possible. While I am overjoyed to share in this victory with them today, there hasn't always been joy at my legal status. This was because of a decision my parents made for me when I was only three years old. This decision would have profound ramifications in my life; one that would carry over into my

adulthood. Today as a parent myself, I can sympathize with the decision my parents made in bringing me to the U.S. without proper documentation. My mom and dad were doing what they thought was in the best interest of their child like many parents do.

It was almost a year ago now that I heard of Jeanette Vizguerra, a mother in Denver who took refuge in the basement of a church as she faced the risk of deportation and ultimately separation from her documented

children. While I do not condone doing illegal acts by any means my immediate thought at this news story was that of my parents' choice to bring me to this country illegally. The children of undocumented parents are children and should not be penalized for the actions of their parents. I felt it in my soul to do something, anything. I knew of a great law firm in my area so I reached out to them. Soon after I went to the law offices of Gardner & Mendoza and shared a little bit of my story. I shared how I could see myself in Ms. Vizguerra being a mom myself. There is nothing more heartbreaking to me than to see families being separated due to deportation. To be snatched away from your children would be devastating to any parent. Yet, this occurs all the time.

While I am not aiming to persuade anyone to change their political affiliation, the intention behind sharing this is that if we can empathize and put ourselves in the shoes of other parents, if we can look past political/ legal bureaucracy and do what is in the best interest of ALL children, undocumented or not, then maybe we can keep families united. Again, I want to share my absolute love for this country and the premise it was built under that all humans "are created equal, that they are endowed by their Creator with certain unalienable Rights, that among these are Life, Liberty, and the Pursuit of Happiness...."

Did I already mention I was sworn in as an American citizen?


